Complete the application below to purchase 2024 Outdoor Aquatic Memberships for access to Flick and Roosevelt Aquatic Centers. Children under 2 years by June 1 do not require a membership. Memberships are not transferrable and cannot be shared.

Each name listed below will receive their individual Glenview Park District ID card to gain access to Flick and Roosevelt Aquatic Centers. All photos must be updated within the last two years. Visit Park Center or one of the three aquatic facilities to update photos or replace missing cards.

A 10% cancellation charge per membership will be assessed on all membership refunds requested prior to the opening of the outdoor pool season. No refunds will be issued after June 12, 2024 except in the case of injury or medical condition (proof required); on such refunds, the amount of the refund will be prorated and a service fee will be assessed.

Memberships are issued based on those who reside at the same residence. New residents or changes in residency within park district boundaries are required to provide proof (gas, electric, or water bill, current tax bill, purchase agreement or lease).

**GET-IT Pass** balances are available to all current outdoor pool membership I.D. card holders within the same household. All memberships under the same household will have access to the money on deposit in the GET-IT Pass account. GET-IT Pass balances are non-transferable. The balance at the end of the season will be refunded by 10/5/24. No refunds will be issued for any balance of \$5 or less.
